The Original Weka Post is a wet, solid radiata pine timber product that is manufactured locally for use within the residential and commercial sector.

The Weka Post is available as a gauged 2.4m length. It is visually graded and treated to H4.

Scope of use

The Original Weka Post may be used in outdoor situations dependent on the specified treatment level. It is visually graded to a No.1 frame.

Conditions of use

Installation requirements

The Original Weka Post is to be installed in accordance with good building practice or as detailed by s Chartered Professional Engineer.

Quality Assurance

ATS Timber has strict quality assurance processes in place to monitor that The Original Weka Post adequately satisfies structural and visual requirements.

Sustainability

The Original Weka Post is sawn from plantation pine grown in New Zealand and is manufactured at our local sawmill. Please see supporting documents for further information.
