Decking widths are 90x32 and 140x32 and in 4.8 and 6.0m lengths. Weka Decking comes either H3.2 CCA or H4 CCA. H5 available on request.

Scope of use

Weka Decking boards are for use in outdoor situations dependent on the specified treatment level and is visually graded for quality with minimal defects but visible character within the wood grain.

Installation requirements

Weka Decking boards are to be installed in accordance with good building practice or as detailed by a Chartered Professional Engineer.

Weka Decking requires an annual clean plus sanding and staining every 1-2 years.
